# Community Needs Assessment

- The first activity for this grant is to complete a community needs assessment.
- A CNA is a survey that identifies the strengths and current resources of a community. The goal is to develop a community action plan to utilize resources and strengths to the community's benefit.
- We will be using the Plested, Jumper-Thurman, and Edwards (2020) Community Readiness Manual.
- Many of you have completed this needs assessment many times.
- If you have used this CNA within **2 years** you do not have to complete it again. Just send the completed CNA to the team.
- If you have NOT completed this CNA in that time frame or at all, you will have 6 months to complete it.

# What data do we need to submit to SAMHSA?

- See list included in your packet.

Data Needed for 988 grant to submit to SAMHSA

1. The number of **people supported** by these funds in the mental health and related workforce trained in mental health-related practices/ activities that are consistent with the goals of the award.
2. The number of **individuals screened** for mental health or related interventions.
3. The number of **individuals referred** to mental health or related services as a result of the award.
4. The number and percentage of **individuals receiving** mental health or related services after referral.
5. The number of **organizations** that entered into formal written/ intra-organizational agreements (i.e. MOUS/ MOAs) to improve mental health related practices/ activities that are consistent with the goals of the award.

# Data contd.

Within 3 months of grant award with the goal of identifying progress and/or barriers we will collect

- 1. Relevant documents** and materials including activity logs, meeting minutes, fiscal reports, evaluation presentations, and grant-related documents. The team will review these to gauge success in anticipated goals.
- 2. Fidelity data** will be collected continuously regarding **Evidence Based Practice training** implementation.
3. Evaluations of **trainings** will be conducted related to **satisfaction** with the curriculum, usefulness of training materials, and integration of learning into practice.
