Data contd.

Within 3 months of grant award with the goal of identifying progress and/or barriers we will collect

- **1. Relevant documents** and materials including activity logs, meeting minutes, fiscal reports, evaluation presentations, and grant-related documents. The team will review these to gauge success in anticipated goals.
- 2. Fidelity data will be collected continuously regarding Evidence Based Practice training implementation.
